Terms & Conditions :-

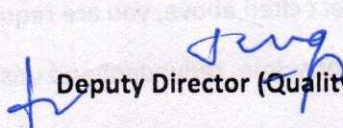
1. Only the Government-authorized vendors/e-waste recyclers shall be eligible to participate in the auction.
2. Each bidder shall deposit an Earnest Money Deposit (EMD) of ₹1,000/- in cash before the commencement of the auction. The EMD of unsuccessful bidders shall be refunded immediately after completion of the auction. The EMD of the successful bidder shall be adjusted towards the bid amount

3. The electronic items shall be sold on "As is where is", "As is what is" and "No Complaint" basis.
4. The bidders are advised to inspect the material before participating in the auction on any working day between 10AM to 5PM. No complaint regarding the quantity, quality or condition of the material shall be entertained after the auction.
5. The auction shall be conducted through Open Boli (Open Outcry). The bidder quoting the highest rate (H-1) shall be declared the successful bidder, subject to approval of the Competent Authority.
6. The successful bidder shall deposit 50% of the accepted bid amount on the same day immediately after the conclusion of the auction.
7. The balance 50% of the bid amount shall be deposited within the next working day. In case of failure, the bid shall be liable to cancellation and the EMD/amount already deposited shall stand forfeited.
8. The successful bidder shall lift the entire material from the office premises within two (02) days after depositing the full bid amount, at his own cost and risk. No loading, unloading or transportation charges shall be borne by the department.
9. All applicable taxes, duties and other statutory liabilities, if any, shall be borne by the successful bidder.
10. The department reserves the right to accept or reject any or all bids or to cancel/postpone the auction without assigning any reason.
11. The decision of the Competent Authority in all matters relating to the auction shall be final and binding on all participants.

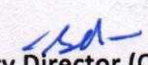
